

**MINUTES OF RAVENNA CITY COUNCIL MEETING**  
**November 4, 2019**

The Regular Meeting of Council of the City of Ravenna was called to order at 7:00 P.M., November 4, 2019, by Council President, Joseph Bica.

A moment of meditation and silence was then observed. President Bica then led those in attendance in the Pledge of Allegiance to the Flag of the United States of America.

**MINUTES:** A motion was made by Mr. Ribelin, seconded by Mr. Moskun to approve the minutes of the Regular City Council Meeting of October 7, 2019. **Voice Vote: All Ayes.**

**COMMUNICATIONS:** The clerk noted a Notice to Legislative Authority was received earlier in the day. This is for a new carryout license at the Chipotle Mexican Grill at the Giant Eagle lot.

There being no objection, the clerk was directed to send in the appropriate documentation to the State of Ohio Liquor Control Board.

The clerk noted there was a letter received from the State of Ohio regarding the November 7 appeal hearing regarding the Den Lounge. That appeal has been withdrawn.

The clerk said that a proclamation was received from Cin-Day Lucky Dogs Browns Backers. Ravenna was chosen to be the Browns Backers Suburb of the week. That was the week of October 7.

Mr. Cimino said the Den appeal was the final appeal. They failed to file a timely request to allow them to continue to be opened pending the appeal. It was too late when it was filed. That was denied. This is the full hearing on the request to overturn the decision by the Department of Liquor Control. This finalizes the issue.

**DELEGATIONS:** Mr. Rick Walden was scheduled. However, he did not appear. There were no other delegations from the public wishing to address Council.

**REPORTS OF OFFICIALS:** There being no other comments, a motion was made by Mr. Kairis, seconded by Mr. Moskun to accept the reports of officials. **Voice Vote: All Ayes.**

**REPORT OF COMMITTEES:** President Bica said Committee meetings will be held Tuesday, November 12, 2019 starting at 5:30 PM.

**Utilities:** Mr. Moskun said this committee had nothing to report.

**Information Systems:** Ms. Michael said this committee will be meeting November 12, time to be announced.

**Planning Committee:** Mr. Kairis said this committee had three items on the agenda. A meeting will be held November 12, time to be announced.

**Committee of the Whole:** President Bica said Committee of the Whole meeting will be held Monday, November 18, 2019 at 7:00 P.M.

**Public Health & Safety Committee:** Mr. Kluge said this committee was sponsoring three items on the agenda. A meeting is to be determined.

**Streets & Sidewalks Committee:** Mr. Harper said this committee was sponsoring one item on the agenda. If a meeting is needed it will be held November 12.

**Personnel:** Mr. Rainone said no items are on the agenda. If a meeting is required, it will be held November 12.

**Community & Economic Development:** Mr. Ribelin said there are no items on the agenda being sponsored by this Committee. If something comes up, a meeting will be held.

**Cemetery:** Mr. Ribelin said the negotiations regarding the \$100,000.00 bequeathed to the cemetery have been completed. They have hired two landscape architects; both will handle different facets. He thinks it will be good for the cemetery. He will be leaving at the end of his term and there will be a new person coming on. That person will need to be appointed at the joint meeting of Council and Township Trustees. He really hopes the plans get implemented.

Ms. Michael said that Mr. Ribelin is actually one of the few who can attend the cemetery meetings because they are held during the day. She expressed her concern that most everyone else has a job and work at during the day.

Mr. Ribelin responded he has somebody in mind who will probably be able to attend the meetings. He'll have more information on that later. They also have a new clerk treasurer. They hated to lose Mrs. Nething who was their clerk treasurer for over 20 years.

**First Reading of Ordinances:**

**ORDINANCE NO. 2019-109:** AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH PORTAGE COUNTY REGIONAL PLANNING COMMISSION TO PROVIDE FAIR HOUSING SERVICES TO THE CITY AS PART OF THE FY 2019 COMMUNITY DEVELOPMENT PROGRAM GRANT, AND DECLARING AN EMERGENCY, was read for the first time, by title only.

Mr. Ribelin said this simply authorizes the mayor to enter into an agreement with Portage County Regional Planning Commission to provide fair housing services to the City of Ravenna as part of the 2019 CHIP grant.

Mr. Harper seconded the motion. **Vote: All Ayes.** Ms. Michael moved to approve this Ordinance as an emergency measure for the reason set forth in the Ordinance. The motion was seconded by Mr. Ribelin. **Vote: All Ayes.** A motion was made by Mr. Ribelin, seconded by Mr. Kluge that Ordinance No. 2019-109 be adopted. **Vote: All Ayes.** The President of Council declared Ordinance 2019-109 adopted.

**ORDINANCE NO. 2019-110:** AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH HERITAGE OHIO, INC., FOR THE CITY'S PARTICIPATION IN THE OHIO MAIN STREET PROGRAM, APPROPRIATING THE SUM OF \$500.00 FROM THE GENERAL FUND TO PAY FOR THE CITY'S PARTICIPATION IN THE PROGRAM, was read for the first time, by title only.

Mr. Kairis explained that this is a yearly agreement the City enters into with Heritage Ohio which governs the Main Street Program. The two components the City needs to provide for this is a \$500.00 yearly fee and the hope that someone on City Council will attend training, which is already done. This authorizes the mayor to sign that agreement. He will abstain because he is a member of the Board of Directors for Main Street. Mr. Rainone is abstaining because his wife is on the board.

**ORDINANCE NO. 2019-111:** AN ORDINANCE AUTHORIZING THE MAYOR TO APPLY FOR A WILDLIFE GRANT THROUGH THE OHIO DEPARTMENT OF NATURAL RESOURCES, TO BENEFIT THE KIDS FOR CONSERVATION PROGRAM IN THE PARKS & RECREATION DEPARTMENT, AND DECLARING AN EMERGENCY, was read for the first time, by title only.

Mr. Kairis explained this is one of two different \$500.00 grants. Both Judy Watkins and Jill Halligan have been trained by ODNR in order to qualify to even apply for these grants. This is an outdoor learning lab as part of the summer day camp. It will be at City Park.

**ORDINANCE NO. 2019-112:** AN ORDINANCE AUTHORIZING THE MAYOR TO APPLY FOR A WILDLIFE GRANT THROUGH THE OHIO DEPARTMENT OF NATURAL RESOURCES, TO BENEFIT THE PARKS & RECREATION DEPARTMENT "EDUCATIONAL POLLINATORS IN THE PARK PROGRAM", AND DECLARING AN EMERGENCY, was read for the first time, by title only.

Mr. Kairis said this is the second \$500.00 grant. It will be for educational pollinators, about bees, and held at Chestnut Hills Park.

There being no further comments or questions, Mr. Ribelin moved to waive the requirement that legislation be read at three separate meetings. Mr. Harper seconded the motion. **Vote: All Ayes.** Mr. Harper moved to approve this Ordinance as an emergency measure for the reason set forth in the Ordinance. The motion was seconded by Ms. Michael. **Vote: All Ayes.** A motion was made by Ms. Michael, seconded by Mr. Kairis that Ordinance No. 2019-112 be adopted. **Vote: All Ayes.** The President of Council declared Ordinance 2019-112 adopted.

**ORDINANCE NO. 2019-113:** AN ORDINANCE APPROPRIATING THE SUM OF \$20,000.00 FROM THE SEWER FUND FOR THE PURCHASE AND INSTALLATION OF A CENTRIFUGAL PUMP FOR THE MAPLEWOOD LIFT STATION, AND DECLARING AN EMERGENCY, was read for the first time, by title only.

Mr. Moskun said this pump was a necessity for the operation at the school. Without it, the school would have to shut down. It's a very integral part of the wastewater treatment system.

There being no further comments or questions, Mr. Kairis moved to waive the requirement that legislation be read at three separate meetings. Mr. Ribelin seconded the motion. **Vote: All Ayes.** Mr. Kluge moved to approve this Ordinance as an emergency measure for the reason set forth in the Ordinance. **ORDINANCE NO. 2019-114:** AN ORDINANCE APPROPRIATING THE SUM OF \$20,000.00 FROM THE SEWER FUND FOR THE PURCHASE AND INSTALLATION OF NEW GATE VALVE ASSEMBLIES AT THE WASTEWATER TREATMENT PLANT, AND DECLARING AN EMERGENCY, was read for the first time, by title only.

Mr. Moskun explained the valves at the wastewater treatment plant are at the end of their life. There are times they get frozen up and are almost totally inoperable. They are at the point where they had to be replaced because of the amount of time it takes to operate those, it wasn't profitable for the department any more.

Mr. Moskun said there are specific chemicals required by the EPA for treatment purposes. This is a yearly housekeeping measure.

President Bica said this is the shared responsibility between the City and the County with regard to meter calibration, maintenance and repair. There was a line item built into the budget for the potential repairs of meters if needed. Every other year responsibility is taken by one of the entities. The City has the first year. This is a contract explaining how this is going to be done.

Mr. Cecora said this is the official abatement agreement for Springseal. The application is there for Mr. Knapp. The most important as part of this exhibit, from the Ravenna School Board, its ratification, waiving the 45 day notification period; agrees to the 100% tax abatement and addresses the supplemental compensation agreement that will exist between Springseal and Ravenna Schools.

Ms. Michael said thank you to Mayor Seman. That is another form of economic development he successfully completed.

Mayor Seman said the Mark and Chris Knapp have been very good people to have move into the City of Ravenna. Chris Knapp runs the business there that does billing for fire departments across northern Ohio. Mark is always looking for a way to expand, getting into other opportunities. He is glad the City was able to help. The school was very good about getting this together. The school's theory on these things is that it's not money they are going to lose because they don't have it now. They will eventually get it. If it's good for the City and provides jobs, they support it and go along with the 100%.

Mr. Cecora said the expansion will be between 25,000 to 40,000 square feet at a cost of an estimated \$1.2 million and 15 fulltime equivalent jobs at the end of three years.

**New Business:** Ms. Michael said for those who don't have kids in school, they may not have gotten a robocall. Tomorrow night at 6:30 at the high school, the school will be having a meeting to go over the community plan. She encourages all residents to attend. She thinks representatives from City Council should be there as well because there are a lot of big changes the schools will be facing. It's unfortunate they chose election night but people should be able to get out to vote and then get there on time.

Mr. Ribelin said in the Record-Courier there are articles from the 1960's. In 1960, the Ward IV councilman, Cyrus Plough, addressed council about protecting Ravenna's water rights. They were in the process of switching from wells. He said we have to get a hold of and purchase land to have a reservoir and the water should come from the Congress Lake area. That's what they have now. Apparently he was pretty prophetic in that statement. There was also an article about Skeels and McElrath. In 1968 the average income in McElrath and Skeels was \$6,800.00 per household. They talked about unemployment rates that most of the kids didn't have more than an eighth grade education because they had to drop out. There was no running water or sewers there. He can testify there were some dirt floors in some of those houses. He thinks they have come a long way. The City provides water for the township, of which they are part. They also provide sewer service in those areas. Even though they have come a long way and both those areas are so much nicer than they were. They've got a long way to go yet. They are our neighbors and he thinks it's important to remember what it was and what it can be. He thinks Mayor Seman has done a good job in expressing that the people in the township are our people. He totally agrees with that.

Mayor Seman said that's the way it was in the schools. There have been a number of new homes built in both areas. The economics of the area are picking up dramatically. Habitat for Humanity built a beautiful home in Skeels. The land bank is helping to consolidate some of the lots. The lots are so small they aren't buildable. The land bank is acquiring those, getting them blocked so they can meet the zoning requirements. This is a very active group.

**Mayor's Remarks:** Mayor Seman said on Fox 8 did some filming in Portage County, doing an eye on Portage County. They were filming interesting places to visit or stop at. Three of them are in Ravenna; Popped was one where they did extensive interviews and filming on candy making that day. The Sunshine Cupcake was one and the third was Bear's Motorcycle Emporium. If they haven't been inside of Bear's they'd never believe everything inside that building. It is a destination place for bikers to buy parts. Sunshine Cupcakes has become a destination place. It was interesting to see it on television today.

Mayor Seman said as far as development goes in the area of places that need to be fixed up, there will be a new convenience store going into building on the corner of Highland and Chestnut. They have been to the Planning Commission and will remodel that store and repave the parking lot. It will be a nice improvement for that neighborhood.

Mayor Seman went on to say that he would like to congratulate Main Street Ravenna. They just received an evaluation this past week. It is unusual for a first year to get a full blown accreditation, but they did everything they were supposed to do. There are certain criteria. Going for training, which Mr. Kairis has been doing, is a point to go toward the accreditation. They are looking for great things coming from them as they proceed into the next year. If anyone has any comments or ideas regarding the signage that was presented, they are looking forward to moving that farther ahead. Please contact Julie if you have anything you would like to see.

Mayor Seman also noted that Deluxe Pastry Shop is reopening again tomorrow. We need to support them. There have been a lot of people invest money in businesses in Downtown. They need traffic and people need to shop here in town.

Mayor Seman said one other thing that deserves mention, noting an award received and asking Chief Wallis to contribute.

Chief Wallis said every year the mental health board asks the Chiefs of Police to recommend one of their officers for a Crisis Intervention Team. He recommended Scott Krieger. He was selected with two other individuals, one Kent officer and one Kent State officer, were honored last week at NEOMed.
