The Special Meeting of Ravenna City Council was called to order at 6:16 P.M. by Council President, Andrew Kluge.

The Clerk read the Call to the Special Meeting stating the purpose of the meeting is to discuss and/or act upon Ordinance No. 2020-120 and Ordinance 2020-121 regarding an MOU between the City of Ravenna, and the Patrol Officers and the Dispatch/Clerks and Secretary's union.

ORDINANCE NO. 2020-120 AN ORDINANCE APPROVING A MEMORANDUM OF UNDERSTANDING TO AMEND THE COLLECTIVE BARGAINING AGREEMENT BETWEEN THE CITY OF RAVENNA, OHIO AND THE FOP OHIO LABOR COUNCIL, INC. DISPATCH/CLERKS AND SECRETARY'S , AND DECLARING AN EMERGENCY.

Ms. Michael stated that the MOU was talked about in Committee and there was nothing more to do other than approve it.

Chief Wallis stated that the MOU is straightforward. The reason for it is because a lot of new hires are in the middle of the year and therefore they were not getting the full amount of clothing allowance and the remainder has to come out of their own pocket, adding that the initial cost is pretty expensive.
