ORDINANCE NO. 2022-109 AN ORDINANCE AUTHORIZING THE OHIO DEPARTMENT OF TRANSPORTATION (ODOT) TO CONDUCT A MUNICIPAL BRIDGE INSPECTION PROGRAM IN RELATION TO THE PROSPECT STREET BRIDGE LOCATED WITHIN THE MUNICIPAL CORPORATION OF THE CITY OF RAVENNA, AND DECLARING AN EMERGENCY.

ORDINANCE NO. 2022-110 AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH HAMMONTREE ASSOCIATES TO PROVIDE LAND SURVEYING SERVICE FOR THE WEST MAIN STREET WIDENING PROJECT AND APPROPRIATE \$15,000 FROM THE ANNUAL PAVING PROGRAM, AND DECLARING AN EMERGENCY.
