 - c. Same type ECM panel that has the height & letters which will be a full digital print on it.

- o Mr. Finney:
 - a. Packet from the state has been received to move forward with consultant.
 - b. Approved \$18,000
 - c. City Council had previously approved \$12,000.
 - d. Moving it to City Council to accept and approve Mayor Seman to sign the document.
 - e. City Council and Design Review had previously approved Perspectus.
 - f. Perspectus is working on a contract specifically to our needs. They are going to address Economic Development.
 - g. Perspectus had already been approved by vote and hoping to move this forward.
- o Mr. Soudil:
 - a. His only fear, because he thought that CT Consultants was better, is that Perspectus is an architectural firm and when interviewed, they sidestepped every question about anything to do with our businesses down there.
 - b. He fears some of that because business is important downtown here and he hopes that Perspectus falls through and hopes that they talk about the businesses and interview those businesses and see what they think about this to make the growth downtown.
- Mr. Silenius:
 - a. Perspectus is a company that is an architect company. CT Consultants is an Economic Development company. Would like the Design Review Commission, DRC, to change their recommendations.

- b. Feels that if all the empty storefronts and rent paying businesses..... property owners would have more money to properly maintain the historic buildings.
- c. Hoping that the DRC would like to know what could be done differently so more people would like to shop and do business in Ravenna.
- d. Asking the DRC to reconsider their recommendation to council.
- e. CT could provide some useful suggestions.

o Mr. Soudil:

a. Put a motion on the floor to revote and who wants to go with Perspectus or CT Consultants.

o Mr. Seman:

- a. Need to check with Mr. Cimino, the Law Director, before anything is changed.
- b. The council will not vote on anything without a contract.

o Mr. Soudil:

a. Rescinded his motion.
