



**Ravenna City Council
Special Meeting Minutes
June 22, 2026**

The public meeting was held in person in Ravenna City Council Chambers.

The Special Meeting of Ravenna City Council was called to order by Council President, Rob Kairis at 6:28 pm.

The Clerk read the Call for the Special Council meeting which was to discuss and/or act upon Ordinance 2026-099 to replace the Clearwell Motor, Aerator and Mixer at the Water Treatment Plant and an executive session to discuss current legal matters with the city's attorney.

ORDINANCE NO. 2026-099 AN ORDINANCE AUTHORIZING THE PURCHASE OF A NEW CLEARWELL MOTOR, AERATOR AND MIXER FOR THE WATER TREATMENT PLANT AND APPROPRIATING \$69,771.25 FROM FUND 670, AND DECLARING AN EMERGENCY.

Mr. Kairis stated that the ordinance was sponsored by the Utilities Committee.

Mr. Moskun noted that he had explained the item during the previous Committee of the Whole meeting. The original equipment has been rebuilt multiple times and is past its life expectancy.

Mr. Kairis reminded Council that the ordinance appropriated \$69,771.25 for the purchase of the Clear Well motor, aerator and mixer.
